

# Agreement to Participate in the Delta Alternative Compliance Plan (DACP)

for Annual Supplemental Statement of Water Diversion and Use Reporting  
Beginning with Reports for Water Year 2022 and  
for Annual Water License Reporting Beginning with Reports for Water Year 2023  
(Updated April 18, 2024)

(January 22, 2024 updates to the original WY 2022 version of this Agreement are shown in red text and pertain only to the Statement Number annual Participation Fee for Places of Use outside the CDWA and SDWA.)

(April 18, 2024 updates to the original WY 2022 version of this Agreement are shown in green text and pertain only to the inclusion of Water License reporting through the DACP.)

## Plan Administrators:

The Central Delta Water Agency (CDWA) and South Delta Water Agency (SDWA).

## Overview of the DACP:

The CDWA and SDWA developed the DACP in collaboration with the Delta Watermaster and numerous other Delta interests in the “Delta Measurement Experimental Consortium” to serve as an “alternative compliance plan” to address the new water measurement laws that were adopted in 2015-2016. The plan is an alternative to installing physical metering devices on every siphon, pump, floodgate or other point of diversion that provides water to a place of use within the Legal Delta.

**For Statement Number reporting** under the DACP, in lieu of reporting how much water is moved through each point of diversion, the DACP will, instead, report the overall consumptive use of water within the place of use served by each point of diversion. The consumptive use information under the DACP will be derived from satellite information collected by “OpenET” (<https://openetdata.org/>).<sup>1</sup>

**Water License reporting under the DACP utilizes a “Non-Duplicative Reporting Methodology” that avoids duplicative reporting of water diversion and use amounts in Water License reports and Statement Number reports in situations where the entire place of use of the License is also covered by one or more Statement Numbers.**

The DACP was prepared in conformance with the new water measurement laws and filed with the Delta Watermaster’s Office on December 21, 2021. Diverters who participate in the DACP, and comply with the terms and conditions of the DACP, will be in compliance with those measurement laws.

## DACP Eligibility Requirements:

- **Only** Statement Numbers (“SO\_\_\_” numbers) **and Water Licenses (“A0\_\_\_” numbers)** are eligible for participation in the DACP. **(Water Licenses (“A0\_\_\_” numbers) are not currently eligible.)**

- The Place of Use of the Statement Number **and Water License** must be located within the Legal Delta.
  - See attached map of the boundaries of the “Legal Delta” (as defined by Water Code section 12220). The “Legal Delta” includes both the “primary” and “secondary” zones depicted on that map.

### **Participation Fee for Places of Use Outside the CDWA and SDWA:**

There will be no cost to participate in the DACP for diverters with Places of Use located within the CDWA or SDWA that pay the annual assessments of those agencies (some state agencies do not pay those assessments and will have to pay the below Participation Fee). (See attached map of the boundaries of the CDWA and SDWA.)

Because the CDWA and SDWA have shouldered the costs to create the new software and website for the DACP, and because they will continue to incur costs to implement the DACP and keep it operational, there will be an annual Participation Fee for diverters with Places of Use located outside the CDWA and SDWA. The Participation Fee will be a charge per acre based on the acreage of the Place of Use of the Statement Number(s) enrolled in the DACP.

The annual Participation Fee is expected to be the highest for the first year because of the substantial startup costs. The fee for **Statement Number reports** for the first year (**i.e., Water Year 2022**) will be **\$1.20 per acre**.

**The fee for Statement Number reports for the second year (i.e., Water Year 2023) will be \$0.45 per acre.**

**There is no fee for any DACP participant for Water License reports for Water Year 2023.**

### **Term and Termination:**

Unless terminated as provided below, participation in and coverage under the DACP for the enrolled Statement Number(s) **or Water License(s)** will continue from water year to water year so long as reporting through the DACP is allowed by the State Water Resources Control Board (SWRCB) and/or the Delta Watermaster.

Participation is voluntary. The owner or authorized representative of the owner of each Statement Number **or Water License** enrolled in the DACP may, by written notice to the Plan Administrators, voluntarily terminate participation in and coverage under the DACP at any time and for any reason. Upon such termination, the owner of the Statement Number **or Water License** shall be solely responsible for timely and fully complying with all water diversion and use measurement and reporting requirements of the SWRCB, independent of the DACP.

The Plan Administrators may terminate a Statement Number **or Water License** owner’s participation in and coverage under the DACP due to any of the following:

1. The Statement Number **or Water License** owner’s failure to timely prepare and submit annual water reports through the DACP for its enrolled Statement Number(s) **or Water License(s)**.
2. The Statement Number **or Water License** owner’s failure to satisfactorily respond to the Plan Administrators’ reasonable requests for information that may be necessary to facilitate the

preparation and filing of annual water reports through the DACP (e.g., a request for clarification of the Place of Use of an enrolled Statement Number).

3. The Statement Number owner's failure to timely pay Participation Fees for an enrolled Statement Number that has a Place of Use located outside the boundaries of the CDWA and SDWA.

In the event such termination for cause is sought, the Plan Administrators will provide prior notice to the Statement Number **or Water License** owner of the basis for the proposed termination, allowing the Statement Number **or Water License** owner fifteen (15) calendar days to correct such failure prior to termination. Upon non-correction of such failure, a notice of actual termination for cause may be sent to the Statement Number **or Water License** owner with termination effective the day after the notice is sent. The notice of proposed termination and notice of actual termination will be sent to the Statement Number **or Water License** owner's email address and paper mailing address on record with the DACP.

Any Participation Fees paid prior to either voluntary or for cause termination will not be refunded; however, the terminated Statement Number owner will not be invoiced for any further Participation Fees.

### **Certifications and Acknowledgments:**

1. I certify that I am the owner, or authorized representative of the owner, of the Statement Number(s) **and/or Water License(s)** for which annual water reports will be submitted through the DACP's website.
2. By submitting those reports through the DACP's website, I acknowledge that I am enrolling the Statement Number(s) **and/or Water License(s)** in the DACP for participation in and coverage under the DACP, and I agree to be bound by the terms and conditions of the DACP set forth in this agreement for each of those Statement Number(s) **and/or Water License(s)**.
3. I certify to the best of my knowledge that the Place of Use of each enrolled Statement Number(s) **and/or Water License** is~~are~~ located within the Legal Delta.
4. I acknowledge that if the Place of Use of an enrolled Statement Number is located outside the boundaries of the CDWA and SDWA, the owner is required to pay a Participation Fee for such Place of Use, and I agree that, upon receipt of an invoice from the Plan Administrators, payment for such a fee will be timely submitted to the Plan Administrators.
5. I acknowledge that the owner of the enrolled Statement Number(s) **and/or Water License(s)** shall be solely responsible for any fees, charges, assessments or civil liabilities incurred by or charged against the water rights and/or claims designated by the Statement Number(s) **and/or Water License(s)**. Neither the DACP, nor its Plan Administrators, shall in any manner be responsible for any such fees, charges, assessments or civil liabilities.
